1. **Opening Comments**

The Chair welcomed members to the meeting and stated this was the first time the Community Councillors had met face to face for over two years and also welcomed Cllr. Day who was in attendance over Zoom.

5. Minutes of the meeting held on the 1st March 2022

The minutes were accepted as a true record and signed by the Chair.

6. Matters Arising

All matters arising were on the agenda and would be dealt at that time.

7. Correspondence and Information

a. Kid's Cancer Charity Funding Request Request rejected as it is the policy of the Community Council to only support local charities **b.** Response from Talgarth Town Council in reference to letter sent to the minister of Climate Change. TTC have now decided not to endorse the letter and therefore the letter has been sent to the Minister in Gwernyfed Community Councils name. The letter has since been acknowledged.

c. Request from Talgarth Town Council to contribute to the purchase of Jubilee Coins for pupils living in Gwernyfed Community Councils area who attend Ysgol y Mynydd du Talgarth . This request was not supported as Gwernyfed Community Council are purchasing Commemorative Mugs for all children living in the Community Council area.

d. Stewart Lawrie- Excess speed A428 and Hay Road B4350 – This correspondence requested the 40mph limit be reduced to 30mph and asked if the Community Council could investigate. A response has been sent explaining the Community Council had successfully negotiated a reduction to 40mph at a cost of £3090 and had been advised that a further reduction would not come under future consideration. Mr Lawrie was also advised, if he so wished, to pursue this issue with the Police and Crime Commissioner.

8. Commemorative Mugs for the Children of Gwernyfed Ward

Cllr. Wheeler requested financial support on behalf of the Felindre Fete Committee to purchase Commemorative Mugs for the children of the Community Council Area, to celebrate the Queens Platinum Jubilee. It was agreed to grant £200 to the Fete Committee.

9. Planning Matters

There were no applications to consider.

10. County Councillors Report

A County Councillor was not in attendance to present a report.

11. Safety Issues

The response from Powys County Councils Right of Way Officer, Martin Davies, concerning the unsafe nature of a stile located at Twin Oaks, which leads onto the nature reserve and a public footpath along the tram line, stated he would investigate the issue when he was next in the area. The clerk has asked for a firm date, still awaiting response. When the response is received Cllr. Day will meet with Mr Davies.

a. Bank Balances of the Current and Reserve Accounts were reported to the meeting. b. Quarterly Report- The clerk presented the quarterly report, the cash book was explained this being the year end position. Income over expenditure was compared to the budget. All variances were accounted for with special reference made to the purchase of defibrillators which were not included in the 21/22 budget.
