1 Opening Comments

AJ welcomed everyone to the meeting

2 Declarations of Interest

4 Minutes of the meeting held on 6th March 2018

Matters Arising

- I ltem 4I MD reported that residents of Felindre are applying to have the status of the Pound Field changed to a village green. Cllr Paul Ashton from Brecon is providing some guidance, and additional information will be sought from the Small Spaces Society. It was agreed by all that this was a good development in the history of this area of the village.
- II ltem 4II AJ reported that the keys are still on order for the noticeboard.
- III Item 4IV It was noted that as JE was not present, there was no update from the Local Authority. The Clerk distributed a page from the website www.crashmap.co.uk which she had been referred to by Dyfed Powys Police. It was agreed to ask Powys County Council for the Engineers report that had been referenced in their recent correspondence.
